Our Legacy Members

All persons who make a legacy gift will be invited to membership in the Payson Wharton Legacy Society, a system-wide group that honors those with the foresight to support health care in perpetuity.

Our membership includes living members who have shared their intentions, as well as deceased members whose legacies are now being fulfilled.

Some of our members have made unrestricted gifts. These gifts will be used for pressing needs across the health system. Unrestricted gifts can be made in honor or memory of a family member or a doctor.

Some members have funded particular causes, such as Otolaryngology, Pediatric Research, and the Hospice Care Network. Some members have designated their local hospitals as recipients, including Glen Cove, Plainview, North Shore University Hospital, Long Island Jewish Medical Center, and Zucker Hillside.

Support the Health System Forever

One of the Health System's priorities is the endowment a perpetual source of funds to cover future health needs, both those we can anticipate and those we cannot. Particularly in times of economic turmoil, it is critical that our hospitals, providers and researchers continue to have a reliable source of funds to enable us to care for the people living in the greater New York metropolitan area—you, your family and friends among them.

We especially need and ask you to consider a gift, in whatever amount, with no restrictions. Unrestricted funds provide flexibility to meet the changing demands of health care. They also provide stability in allowing the Health System to function in areas of greatest need.

If care at a particular hospital or finding a cure for a disease inspires you to make a gift, we would be pleased to discuss your wishes to ensure that your intentions take into consideration future unknowns. Additional language may be advisable if you wish to fund research for a particular disease that may someday be eradicated (e.g., cancer).

Ways to Leave a Legacy

There are a variety of options to enable you to leave a legacy. Cash gifts enable funds to be created now. More traditional "planned" gifts, such as bequests in wills, are used to establish a legacy or to enhance an existing fund.

Gifts can also be established for the ultimate use of the Health System and provide you with an income stream. These gifts can be structured to provide fixed payments or payments that fluctuate. Finally, gifts can be structured to pay an income stream to the Health System for a period of years, after which the principal amount is returned to you or your family.

Legacy Gift Options

Bequest in a Will A gift in your will of a dollar amount, asset, or percentage of your estate

Gift in a Trust North Shore-LIJ can be designated as a beneficiary of a revocable trust or an irrevocable trust

Life Insurance Policy North Shore-LIJ can be designated as an owner and/ or a beneficiary

Retirement Plan/IRA Gift North Shore-LIJ can be designated as a beneficiary

Charitable Gift Annuity A contract between you and North Shore-LIJ reserving a fixed payment for life [*suggested minimum: \$10,000*]

Charitable Remainder Trust A separate entity pays an income stream to 1-2 persons, and the remainder to North Shore-LIJ [suggested minimum: \$100,000]


Charitable Lead Trust

A separate entity provides income to North Shore-LIJ for a term of years, and the remainder to you or your family; used to achieve both charitable and estate planning goals

Guidance for Making a Bequest

A **bequest** (gift in your will) is a great way to create a legacy and support the mission of the North Shore-LIJ Health System.

Unrestricted gifts become part of our endowment, providing care and support well into the future. If you wish to specify a particular or restricted use, we will discuss your specific wishes with you. You may also make a legacy gift in honor or memory of a loved one or a doctor who provided exemplary service.



Specific Bequest: a gift of a specific sum or a specific asset

"I give to the North Shore-LIJ Health System Foundation, of Great Neck, New York, \$_____ [or describe the asset] to be used for its general charitable purposes in honor of my mother."

Residuary Bequest: a gift of part or all of the remainder of your estate

"I give to the North Shore-LIJ Health System Foundation, of Great Neck, New York, _____ percent of my estate to support _____ Hospital."

Contingent Bequest: a gift that requires something to happen/not happen

"If my spouse does not survive me, I give to the North Shore-LIJ Health System Foundation, of Great Neck, New York, \$______ to be used to support cancer research until such time as there is a cure, and then for its general charitable purposes."

Two Popular Ways to Give

A charitable gift annuity. Regardless of the ups and downs in the economy, you can lock in a good rate and receive a fixed income for your lifetime. You will benefit those who need health care in the future while gaining a reliable income stream. In the words of one donor, *"We get to help others and help ourselves!"* With some tax-free income and a charitable income tax deduction, the benefits are even greater. Two recent donors explained, *"We want to keep the neighborhood hospital going, and we like a bit of income, too!"*

Retirement plans and IRAs. The largest asset you may own is an IRA/retirement plan. The original purpose was to provide you with income in your retirement. You can create a legacy by designating North Shore-LIJ as a beneficiary of what remains of your IRA/retirement plan. Assets received by North Shore-LIJ are exempt from both estate and income taxes at the end of your lifetime, so 100% will be put to good use. For other beneficiaries (such as your children), since plan assets are subject to both taxes at death, the effective combined tax rates may be as much as 70%, leaving only 30% to your heirs. (A qualified rollover will defer, but not eliminate, these taxes.)
